ARTICLE 1

ORGANIZATION

1.0 GENERAL PROVISIONS

1.1 — 1.01 GENERAL PROVISIONS

- Name. The name of this organization is AIA/Central Kentucky Chapter, INC, hereafter referred to as this Chapter.
 - 1.1.1.1 1.011 Related Institute Organizations. In these bylaws the governing board of this Chapter is referred to as the Board of Directors. The American Institute of Architects is referred to as the Institute, and the Board of Directors of the Institute as the AIA Board.
- 1.1.2 Objects. The objects of this Chapter shall be to promote and forward the objects of The American Institute of Architects within the assigned territory of this Chapter. The Institute objects are: to organize and unite in fellowship the members of the architectural profession; to promote the aesthetic, scientific and practical efficiency of the profession; to advance the science and art of planning and building by advancing the standards of architectural education, training and practice; to coordinate the building industry and the profession of architecture to insure the advancement of the living standards of people through their improved environment; and to make the profession of ever-increasing service to society.
- <u>1.03</u>Domain. The domain of this Chapter shall be that territory described in its charter or otherwise established by the Institute. The territory of this Chapter is described as follows: Central & Western
 - Kentucky and is the areas within the following listed counties: Adair,
 Ballard, Breckinridge, Bullitt, Caldwell, Crittenden, Cumberland, Daviess,
 Graves, Grayson, Green, Greenup, Hancock, Hardin, Hart, Henderson, Henry,
 Hickman, Hopkins, Jefferson, Larue, Livingston, Marion, Marshall, McLean,
 Meade, Muhlenberg, Nelson, Ohio, Oldham, Shelby, Spencer, Taylor, Trimble,
 Union, Washington, Webster or as designated by the institute. Institute.
 - 1.1.4 1.04 Organization. This Chapter is a non-profit membership corporation incorporated in the StateCommonwealth of Kentucky in 1993, and chartered by the Institute in 1908 and reassumed by the locality in 1968.

- 1.1.5 Authority. This Chapter shall represent and act for the Institute membership within the territory assigned to it under a charter issued by the AIA BoardInstitute. The Institute and this Chapter may act as agent, one for the other, or through a delegated third party, for the purpose of collecting and forwarding dues, acting as custodian of funds, or otherwise; provided that the Institute and this Chapter execute a written agreement to that effect.
- 1.1.6 1.06 Conformity with Institute Policy. No act of this Chapter shall directly or indirectly indirectly nullify or contravene any act or policy of the Institute. This Chapter shall cooperate with its state organization and regional organization to further the interests of the membership and by agreement with these organizations may represent and act for them within the territory of this Chapter.

1.2 1.1 AFFILIATIONS WITH OTHER ORGANIZATIONS

- 1.2.1 Purpose of Affiliations. This Chapter may affiliate with any local organization of the construction industry operating within the territory of this Chapter that is not used or maintained for financial gain, price fixing or political purposes, if and while the objects of this Chapter will be promoted by such affiliation.
- 1.2.2 Agreements of Affiliation. Every affiliation must be authorized by not less than two_thirds vote of the Board of Directors and shall be evidenced by a written agreement signed by the Chapter and the affiliated organization.
 - 1.2.2.1 <u>1.121</u> Statement of Purpose. Every agreement of <u>affiliation</u> shall state the purposes and objects of the <u>affiliation affiliation</u>, the terms and conditions under which it is entered into, the duration, the objects of the affiliate and the nature of its <u>organizationsorganizations</u>, membership, government and operations.
 - 1.2.2. Limitations. No affiliated organization shall have any voice in the affairs of this Chapter and shall not bind or obligate this Chapter to any policy or activity unless the Board of Directors has voted to be so bound or obligated.
 - 1.2.2.3 1.123 Termination. Any affiliation may be terminated by majority vote of the Board of Directors upon such notice to the affiliated organization as may be required in the agreement of affiliation.

1.2.3 Privileges of Affiliated Organizations. The representatives of an affiliated or collaborating organization may attend any of the regular meetings of this Chapter, and may speak at the invitation of the presiding officer.

1.3 1.2 ENDORSEMENTS

ARTICLE 2

ARTICLE - 2 ——MEMBERSHIP

2.1 2.0 GENERAL PROVISIONS

- 2.1.1 <u>2.01</u> Categories of Membership. The membership of this Chapter shall consist of:
 - 2.1.1.1 a) The Architect and Associate members of the Institute who have been assigned to the Chapter, or who have been admitted to unassigned membership in this Chapter, and
 - 2.1.1.2 b) The Professional Allied and Affiliate members Members the Chapter may be admitted as provided in Paragraphs 2.21 through 2.25 Sections 2.4 of these Bylaws.
 - 2.1.1.3 2.02 Architect members may also hold the titles Fellow and/or Emeritus.

 Unless otherwise provided, the term "Associate member(s)" in these bylaws shall be understood to include International Associate members. Although Associate members may also hold the title Emeritus, International Associate members may not hold that title.
- 2.1.2 Definitions. In these bylaws, Architect and Associate members who have been assigned to this Chapter by the Institute are referred to as "assigned members." The term "unassigned member" shall refer to members assigned to other chapters who have been admitted to membership in this Chapter pursuant to section 2.2 Section 2.4 of these bylaws.
 - 2.1.2.1 The term Professional Affiliate "Allied" shall refer to Professional Affiliate members. Allied Members (as defined in Section 2.4.5 of these Bylaws).
 - 2.1.2.2 The term "member" Affiliate" shall refer to Student Affiliates (as defined in Section 2.4.6 of these Bylaws) and Honorary Affiliates (as defined in Section 2.4.7 of these Bylaws).
 - 2.1.2.2.1 The term "Member," if not otherwise qualified, shall refer to all persons in all classes of membership in this Chapter.

- 2.1.3 Qualifications. This Chapter shall not establish qualifications in addition to, or which vary from, the Institute's policies for membership.
- 2.1.4 2.04 Non-Resident Status. Non-resident status shall be accorded to members who reside and have their principal place of business outside the territory of the Chapter and not in the territory of another chapter. Members who have applied for and been granted such status shall have the same rights and privileges as resident members in the same category, except that the Chapter may lower dues and/or assessments for such members as provided in ARTICLE 3.
- 2.1.5 Enrollment of Members. Every member assigned to or admitted by this Chapter shall be duly notified to that effect by this Chapter, and shall be enrolled by the Secretary as a member of this Chapter. New memberships will be announced at the next regular meeting of this Chapter and in the next issue of the Chapter's official publication.
- 2.1.6 Annual Dues and Assessments. Every member of this Chapter shall pay the fixed annual dues and assessments of this Chapter as determined in Article 3.

 ARTICLE 3.
- 2.1.7 Resignations. Any member may resign from this Chapter by presenting a written resignation to the Secretary. The resignation of an assigned member in good standing shall be forwarded to the Institute and will be effective upon its receipt by the Institute. Other resignations shall be effective as of the date the letter of resignation was received by the Secretary.
- 2.1.8 Good Standing Defined. A member is not in good standing in this Chapter if and while in default of dues or other obligations to either this Chapter or the Institute.
- 2.1.9 Loss or Suspension of Interests, Rights and Privileges. A member who resigns, or whose membership is suspended or terminated by the Institute, loses all rights in this Chapter and the Institute, including any right to use the Chapter's or Institute's name, initials, symbol, or seal, until the member is reinstated in good standing. Resignation, suspension or termination of membership does not relieve the individual of the obligation to pay any indebtedness owed to the Chapter.

2.2 ASSIGNED MEMBERS

- 2.2.1 General. The qualifications, rights and privileges of assigned Architect and Associate members shall be as provided in the Institute Bylaws.
- 2.2.2 PROFESSIONAL Action on Applications. Whenever an application for membership in the Institute and assignment to the Chapter is filed with this Chapter, the Secretary or the Secretary's designee shall promptly complete the application and forward it to the Institute. Where the applicant is ineligible under the Institute Bylaws, the Chapter will send a recommendation to the Institute Secretary to deny the application.
- 2.2.3 Admission Fees Prohibited. An assigned member shall not pay any admission or initiation fee for membership in this Chapter.
- 2.2.4 <u>Termination.</u> Assigned membership in this Chapter is terminated by the death of the member, resignation or termination of membership in the Institute, reassignment of the member to another chapter, or as otherwise provided in the Institute Bylaws or these bylaws.
- 2.2.5 Emeritus Members. A member who is granted Emeritus status in accordance with the Institute Bylaws shall automatically become an Emeritus member of this Chapter. All rights, interest, privileges, titles, liabilities and obligations of such members, other than the payment of regular and supplemental dues, shall remain unchanged unless otherwise provided in the Institute Bylaws.

2.3 UNASSIGNED MEMBERS

- 2.3.1 Admission. This Chapter, without action by the Institute, may admit to unassigned membership any Architect or Associate member assigned to another chapter who applies for such membership in writing in the manner prescribed by the Board of Directors.
- 2.3.2 Rights and Privileges. Subject to whatever conditions the Institute Bylaws may provide, an unassigned member shall be subject to all regulations and shall have all rights in this Chapter of an assigned member, except that an unassigned member shall not vote on matters described in Section 5.3.4 of these bylaws, nor represent this Chapter as a delegate or otherwise at any meeting of the Institute.
- 2.3.3 Termination. Unassigned membership in this Chapter is terminated by the death of the member and by resignation or termination of membership in the Institute.
 - 2.3.3.1 The Board of Directors may terminate unassigned membership for indebtedness to the Chapter as provided in Section 3.4 of these Bylaws.

2.4 ALLIED AND AFFILIATE MEMBERS

2.4.1 2.21 Admission. Every application for admission to Professional Allied or Affiliate membership in this Chapter shall be promptly acted upon by the Board of Directors. 2.4.2 2.22 Admission Fees. Every applicant for a Professional an Allied or Affiliate membership shall, except Honorary Affiliate Members, may pay an admission fee in an amount determined by the Board of Directors as provided in section 3.02 Section 0 of these bylaws. 2.23 Termination. Allied or Termination. Professional Affiliate 2.4.3 membership is terminated by the death or resignation of the member and by the admission or eligibility to be admitted as an assigned or unassigned member. The Board of Directors may terminate the membership of a Professional an 2.4.3.1 Allied or Affiliate member Member for indebtedness as provided in section 3.32 or Section 3.4 of these Bylaws or by two-thirds vote of the Board of Directors for conduct detrimental to the interests of the Chapter. 2.24 Rights and Privileges of Professional Allied and Affiliate Members. 2.4.4 Professional Affiliate members Allied Members shall have the rights and privileges specified in the Institute Bylaws. Professional Affiliates, including the use of the phrase "Allied Member of the Central Kentucky Chapter of the American Institute of Architects" to describe themselves. An Affiliate Member in good standing: 1) May serve as a member of any committee of this Chapter that 2.4.4.1 does not perform any duty of the Board of Directors, but may not vote; 2) May attend and speak but may not make motions or vote at any 2.4.4.2 meeting of this Chapter; 3) Shall not be eligible to serve as an officer or director or to chair a 2.4.4.3 committee of this Chapter; — 4) May not in any way use the name, initials, seal, symbol or 2.4.4.4 insignia of this Chapter or of the Institute. 2.25 Professional Affiliate Allied Members. Individuals' not otherwise 2.4.5 eligible for membership in the Institute or the ehapter Chapter may become

Professional Affiliate members Allied Members if they have established professional reputations and are registered to practice their professions where such requirements exist, or are employed outside of architectural practice but are involved in positions allied to the field of architecture. Professional Affiliate members Allied Members may include engineers, planners, landscape architects, sculptors, muralists, artists, and others in government, education, journalism, manufacturing, industry and/or other fields allied to architecture who the chapter believes will provide a meaningful contribution by reason of their employment or occupation.

ARTICLE 3

- 2.4.6 Student Affiliates-Qualifications. Student Affiliates shall be undergraduate or postgraduate students of architecture schools, or secondary school students, within the territory of this Chapter.
- 2.4.7 Honorary Affiliates.
 - 2.4.7.1 Qualifications. A person of esteemed character who is otherwise ineligible for membership in the Institute or this Chapter but who has rendered distinguished service to the profession of architecture, or to the arts and sciences allied therewith within the territory of this Chapter, may be admitted as an Honorary Affiliate Member of this Chapter.
 - 2.4.7.2 Nomination and Admission. A person eligible for Honorary Affiliate membership may be nominated by any member of the Board of Directors. The nomination must be in writing over the signature of the nominator and include the name of the nominee, biography, a history of attainments, qualifications for the honor and the reasons for the nomination. The Board of Directors, at any regular meeting, may admit a nominee as an Honorary Affiliate Member.
 - 2.4.7.3 Rights and Privileges. In addition to the rights and privileges set forth in Section 2.4.4 of these Bylaws, Honorary Affiliate Members of this Chapter may use the title "Honorary Affiliate of the Central Kentucky Chapter," and shall not pay any admission fee or annual dues nor be subject to any assessment.

ARTICLE - 3 DUES, FEES, AND ASSESSMENTS

3.1 3.0 ANNUAL DUES

- 3.1.1 Obligation to Pay Dues. All members except Emeritus members shall pay annual dues on or before January 15 of each year.
- 3.02 Amount of Annual Dues and Admission Fees. The Board of Directors (by the concurring vote of at least quorum) may fix, before the
 - _____end of any fiscal year and in accordance with timing and other requirements fixed by the Institute, the annual dues to be paid by each category of member for the immediately succeeding fiscal year and the amount of admission fees required of Professional Allied or Affiliate members Members.
 - 3.1.3 3.03 Dues Upon Admission. A newly admitted assigned or Professional Allied or Affiliate member Member shall pay full annual dues, except that those admitted during the last six months of the year shall pay one-half the annual dues in the year they are admitted.
 - 3.1.4 <u>3.04</u> Dues For Nonresident Members. Nonresident members shall pay reduced dues. The amount of the reduction shall be determined by the Board of Directors pursuant to section 3.02. Section 0.
 - 3.1.5 General Waiver of Annual Dues and Admission Fees. This Board of Directors, by the concurring vote of not less than two-thirds of its the total number of assigned members present at a meeting, may waive for any fiscal year any part or all of the annual dues required to be paid by any membership class or any part of the admission fee required to be paid by Professional Allied or Affiliate members Members.

- 3.1.6 3.06 Hardship Dues Reduction. The Board of Directors may, in exceptional circumstances, waive all or any part of the annual dues of any member. After consultation with the Institute Secretary and other affected components, the Board of Directors may, in exceptional circumstances, waive all or any part of the dues or fees owed by a member to the Institute and other assigned components, provided that such waiver is in equal proportions across all levels of membership.
- 3.1.7 Exemptions. Emeritus members and Honorary Affiliate

 Members shall pay no dues or assessments to the Chapter. Emeritus members who wish to receive mailings from the Chapter shall pay a fee in an amount determined by the Board of Directors pursuant to section 3.02. Section 0.

3.2 3.1 ASSESSMENTS

3.2.1 Authority. This Chapter, by the concurring vote of a majority of Architect members present at a meeting, may levy an assessment on its Architect members, and by the concurring vote of a majority of its assigned members may levy an assessment on its Associate members and/or Allied or Affiliate Members (other than Honorary Affiliate Members).

of its assigned members present at the meeting may levy an assessment on its Associate members and/or Professional Affiliate members.

- 3.2.1.1 3.12 The amount of the assessment on a member in any fiscal year shall not exceed the amount of the annual Chapter dues required to be paid by such member for that year.
- Notice of Assessment. Notice of the intention to levy an assessment stating the amount, the reasons for the assessment, and when it shall be payable, shall be made available mailed to every member not less than 30 days prior to the meeting of this Chapter at which the proposed assessment is to be voted on, via means determined by the Board of Directors to the members current contact information on file with the Chapter upon.

3.3 3.2 DEFAULT OF ANNUAL DUES AND ASSESSMENTS

3.3.1 <u>3.21</u> Annual Dues. Every member who has not paid the entire amount of required annual dues for the then current fiscal year when due shall be in default for the unpaid amount.

3.3.2 <u>3.22</u> Assessments. Every member who has not paid the entire amount of an assessment on or before the date fixed for payment shall be in default for the unpaid amount.

3.4 3.3 TERMINATION OR SUSPENSION FOR DEFAULT OF DUES OR ASSESSMENTS

3.4.1 3.31 Assigned Members. Termination If an assigned member is in default to the Institute or this Chapter for nonpayment of dues or and assessments, such membership shall be made in accordance with subject to termination.

Institute policy.

3.4.2 3.32 Professional Unassigned Members and Allied or Affiliates. If a

Professional If an unassigned member or Allied or Affiliate member Member is in default to this Chapter for nonpayment of dues and assessments, such membership shall be suspended or terminated. provided that in all cases such member shall have been given a written notice of impending suspension or termination at least 30 days prior to the effective date of such action, during which period the member shall remain in good standing and such default may be cured.

3.4 Reinstatement

3.5 —REINSTATEMENT

Reinstatement in the Chapter shall be automatic for former members who reapply and are accepted for —membership in accordance with Institute policy.

Professional Affiliate Members whose membership has been suspended for nonpayment of dues shall be reinstated in the Chapter upon payment of dues.

ARTICLE 4

-CHAPTER RELATIONSHIP TO

ARTICLE - 4 ——OTHER INSTITUTE ORGANIZATIONS

4.1 4.0 THE INSTITUTE

- 4.1.1 4.01 Delegates to Institute Meetings. This The Chapter's Board of

 Directors President shall select the delegates to represent the assigned membership at meetings of the Institute from among the assigned members of this Chapter in the number prescribed in the Institute Bylaws as follows:
 - 4.1.1.1 <u>4.011</u>Delegate Selection Procedure. Member delegates shall be appointed from among the assigned members of this Chapter by the Board of Directors, except that no more than one third of the Chapter's delegation shall be <u>Associates. Associate Members</u>. If this Chapter neglects, fails or refuses to select all its delegates, or should any appointed delegates fail to be accredited, then the President or a designated representative may appoint delegates to represent this Chapter or execute a proxy as provided in the Institute Bylaws.
- 4.1.2 4.02 Nomination and Election of Institute Directors. The assigned members of this Chapter shall nominateparticipate in the nomination and elect election of the Regional Representatives for this Chapter's region to the Institute Director(s) for this Chapter's region Strategic Council in the manner provided in the bylaws of the Regional State Organization.

ARTICLE - 1 4.1 REGIONAL ORGANIZATION

- 4.11 Chapter Representation in Regional Organization. This Chapter shall participate in the Regional Organization in the manner provided in the bylaws of that organization. The President or another member appointed by the Board of Directors shall represent this Chapter at meetings of the Regional Organization.
 - <u>4.12 Delegates to Regional Meetings</u>. The assigned members in good standing of this Chapter shall be represented at meetings of the Regional Organization by delegates selected from among the

assigned members of this Chapter in the number prescribed in the bylaws of the Regional Organization as follows:

<u>4.121 Delegate Selection Procedure</u>. Chapter delegates to meetings of the Regional Organization shall be selected from among the assigned members of this Chapter by the Board of Directors/members attending the annual meeting of the Chapter.

4.2 STATE ORGANIZATION

4.21 Delegates to State Convention. The assigned members in good standing of this Chapter shall be represented at meetings of the State Organization by delegates selected from among the assigned members of this Chapter by the Board of Directors in the number prescribed in the Bylaws of the State Organization as follows:

<u>4.211 Selection of Delegates</u>. Chapter delegates to meetings of the state organization shall be selected from among the assigned members of this Chapter by the Board of Directors.

- 4.2.1 4.22 Representation on State Organization Board. The President or another member appointed by the Board of Directors shall be a representative of this Chapter in the State Organization. At the annual meeting of this Chapter, the members in good standing of this Chapter shall elect one or more additional representatives, as may be required by the State Organization bylaws, to represent this Chapter in the State Organization.
- 4.2.2 <u>4.23</u> Nominations and Elections. Nominations and elections of Chapter representatives to the State Organization board shall be made at the same time and in the same manner as for the officers and directors of this Chapter.
- 4.2.3 4.24 Term of Representatives. Each representative shall serve for the term of one year, or until a successor is elected or appointed. The Board of Directors shall name the successor of a representative for the unexpired term created by the representative's resignation or, incapacity of any representative, or unwillingness to serve, except that the Vice President shall serve in the case of President's resignation or, incapacity of the President, or unwillingness to serve.

4.3 4.3 SECTIONS

- 4.3.1 Establishment of Sections. This Chapter may establish Sections with the approval of the Institute Secretary.
 - 4.3.1.1 Procedure. Members in a geographic area within the territory of the Chapter may petition the Board of Directors to form a Section.
- 4.3.2 Section Membership Voluntary. Membership in any Section shall be voluntary and not required as a condition of membership in the Chapter or the Institute.
- 4.3.3 Section Dues and Assessments. Sections may levy dues and assessments on members of the section but Section members may not be required to pay them except to the extent provided in the Institute's Bylaws.

ARTICLE 5

ARTICLE - 5 ——CHAPTER MEETINGS

5.1 5.0 REGULAR, ANNUAL AND SPECIAL CHAPTER MEETINGS

<u>5.02 Regular Meetings</u>. This Chapter shall hold monthly meetings at a time and place to be determined by the Board of Directors.

5.1.2 <u>5.03</u> Special Meetings. A special meeting of this Chapter may be called by the President or the Board of Directors and. A special meeting of this Chapter shall be called by the President at the written request of not less than five 5 percent of the total number of this Chapter's members in good standing. No other business than that specified in the notice of the special meeting shall be transacted, and all rules and procedures at the meeting shall be the same as those for an annual meeting.

5.2 5.1 NOTICE, QUORUM, MINUTES FOR CHAPTER MEETINGS

5.2.1 Notice of Chapter Meetings. A notice of each meeting of this Chapter, stating the date, time and place where the meeting will be held, shall be given by the Secretary or by the Secretary's designee personally or by mail or email to each member entitled to vote at the meeting. Notice shall be given not less than five days before the date fixed for the meeting. Notice is sufficient if published in the Chapter newsletter or posted on the chapter web site and/or sent to members in time for them to receive it at least five days prior to the meeting.

- <u>5.12</u> Quorum at Meetings. At any meeting of this Chapter, five percent of the membership entitled to vote shall constitute a quorum for the transaction of any business. The members present may adjourn the meeting despite the absence of a quorum.
- 5.2.3 Minutes of Meetings. Written minutes of every business meeting of this Chapter, recording the matters considered at the meeting and the actions taken, shall be kept by the Secretary. The minutes of each meeting shall be signed by the Secretary after they are approved at a subsequent meeting of the Chapter Board of Directors and thereafter filed in the Chapter's records.

5.3	5.2 I	DECISIONS AT MEETINGS, ELIGIBILITY FOR VOTING
	5.3.1	<u>5.21</u> Majority Vote. Every decision at a Chapter meeting shall be by a majority vote of those members in good standing who are present and voting, unless otherwise required by law or these bylaws.
	5.3.2	<u>5.22</u> Roll Call Vote. A roll call vote shall be taken at the call of the presiding officer or whenever one_third of the voting members present so request.
	5.3.3	<u>5.23</u> Proxies. Unless otherwise required by law, there shall be no voting by proxy at a meeting of this Chapter.
	5.3.4	<u>5.24</u> Limitations on Voting Eligibility. Only assigned members in good standing may vote on the following matters:

ARTICLE - 6 THE BOARD OF DIRECTORS

6.1 6.0 AUTHORITY OF BOARD OF DIRECTORS

- of Directors, which shall be composed of the four chapter officers (President, Vice President, President-Elect, Immediate Past President Secretary and Treasurer) and five6 directors (one AIA Kentucky director and four chapter directors) of this Chapter and shall exercise all authority, rights and powers granted to it by the laws of the State Commonwealth of Kentucky, by the articles of incorporation, and by these bylaws.
 - 6.1.1.1 6.011 Custodianship. The Board of Directors shall be and act as the custodian of the properties and interests of this Chapter except those specifically placed by these bylaws in the custody of or under the administration of the Treasurer. Within the appropriations made therefore, the Board of Directors shall do all things required and permitted by these bylaws to forward the objects of this Chapter.
- 6.1.2 6.02 Delegation of Authority. Neither the Board of Directors nor any officer or director of this Chapter shall delegate any of the authority, rights or power conferred by law or these bylaws, unless such delegation is specifically prescribed or permitted by these bylaws and is not contrary to law.
- 6.1.3 Freedom from Commitments. No committee, commission, officer, director, member, employee or agent of this Chapter shall initiate or carry on any activity that may commit the Chapter to an expense, policy or activity until the matter shall have been reviewed and approved by the Board of Directors.

6.2 6.1 ELECTION OF OFFICERS AND DIRECTORS

6.2.1 <u>6.11</u> Nominations. Nominations for each office (and for each directorship) of this Chapter about to become vacant shall be made at the annual meeting from the floor. In addition, at a meeting of the Board of Directors held at least one month 2 months prior to the annual meeting, the Board of Directors Vice

<u>President/President-Elect</u> shall select a nominating committee to prepare and present to the members a slate or slates of candidates <u>for offices</u> to be nominated <u>for offices</u>. <u>Notification of nominations to membership shall be made at least 30 days prior to elections.</u>

- 6.2.2 Elections. The nominee for an office who receives a majority of the ballots cast at the annual meeting shall be elected thereto. If there is only one nominee for any office or directorship, the Secretary may be directed by the meeting to cast a ballot for the full number of votes of the meeting for that nominee, whereupon the President shall declare the nominee to be elected by acclamation. Otherwise the name of each nominee for each office and each directorship shall be placed by the Secretary on ballots for voting by secret ballot.
- 6.2.3 6.13 Tellers. The President may appoint three tellers, who shall be members qualified to vote at the meeting, and who shall tally the qualified votes for each nominee, tabulate the results and immediately notify the Secretary thereof.
- 6.2.4 6.14 Tie Votes. In the event of a tie vote, the list of nominees for each office and each directorship in question shall be restricted to those involved in the tie, and the nominee receiving a majority in the runoff election shall be elected to the office.
- 6.2.5 Results. The President shall announce to the meeting the results of all balloting, and shall declare all elections.

6.3 6.2 TERMS OF OFFICE OF OFFICERS AND DIRECTORS

— <u>6.21</u> Term. Each officer shall serve a term of one year or until a successor has qualified.

— <u>Each director shall serve a term of 2 years or until a successor has qualified, with staggered terms so that each year 1/2 of the directors' terms will expire.</u> Each AIA/Kentucky director (1) shall serve a term of one year or until a successor has qualified.

Each chapter director (4) shall serve a term of two years with two directors alternating terms each year

- 6.3.1 <u>or serve</u>as AIA/Kentucky director or until a successor has qualified.
- 6.3.2 Vacancies. If a vacancy occurs in the membership of the Board of Directors other than on account of the regular expiration of a term of office, the Board of Directors shall fill the vacancy for the unexpired term of office.

 - 6.4.4.1 <u>6.341</u>Reports. The Secretary shall furnish the Institute, the Regional Organization and the State Organization with such reports as may be required from time to time and at least annually shall furnish the Secretary of each of those organizations with the names and addresses of all officers (and directors) of this Chapter and report changes in the membership as may be required to keep the records of those organizations up-to-date and complete.

- 6.4.4.2 <u>6.342</u> Delegation of Authority. The Secretary may delegate to an assistant secretary or other assistant employed by this Chapter the actual performance of any or all duties as recording or corresponding secretary, but shall not delegate responsibility for the property of this Chapter, or the making of any attestation or certification required to be given by the Secretary, or the signing of any document requiring the signature of the Secretary.
- 6.4.5 The Treasurer. The Treasurer shall have charge and shall exercise general supervision of the financial affairs and keep the records and books of account of this Chapter; prepare the budgets, collect amounts due this Chapter, and give receipts for and have the custody of its funds and monies and make all disbursements of funds; have custody of its securities and of its instruments and papers involving finances and financial commitments; conduct the correspondence relating to the office; and perform all duties usual and incidental to the office.
 - 6.4.5.1 6.351 Reports. The Treasurer shall make a written report to each annual meeting of this Chapter and a written report to each regular meeting of the Board of Directors. Each of said reports shall set forth the financial condition of this Chapter, and its income and expenditures for the period of the report and the Treasurer's recommendations on matters relating to the finances and general welfare of this Chapter.
 - 6.4.5.2 <u>6.352</u> Delegation of Authority. The Treasurer shall not authorize any person to sign any order, statement, agreement, check or other financial instrument of this Chapter that requires the signature of the Treasurer, unless such delegation is expressly permitted in these bylaws. The Treasurer may delegate to an assistant treasurer or other assistant employed by this Chapter the actual performance of any or all duties as Treasurer, but shall not delegate responsibility for the property of this Chapter, or the signing of any document requiring the signature of the Treasurer.
 - 6.4.5.3 <u>6.353</u> Liability. The Treasurer shall not be personally liable for any loss of money or funds of this Chapter or for any decrease in the capital, surplus, and income or reserve of any fund or account resulting from any acts performed in good faith and with reasonable care in conducting the usual business of the office.
- 6.4.6 Officer Pro Tem. If any officer is absent or unable to act, the Board of Directors may elect from its membership an Officer pro tem, Director pro tem, chairman pro tem, a secretary pro tem or a treasurer pro tem, as necessary, who shall serve until the regularly elected officer is able to act, and during such

period shall perform the duties and exercise the power and authority of the office.

6.4. Immediate Past President: The Immediate Past President shall serve as aide, advisor, and mentor to the President and shall perform such other duties as are properly assigned by the Board of Directors or the President.

6.5 MEETINGS OF THE BOARD OF DIRECTORS

 - 6.5.1.1 <u>6.411</u>Regular Meetings. The Board of Directors shall typically hold regular meetings on the second Wednesday of each month without notice at a time and place determined by the Board of Directors.

- 6.5.1.2 6.412 Special Meetings. A special meeting of the Board of Directors shall be held if requested in writing by one-third of the members of the Board of Directors, or at the call of the President. The Secretary shall issue a written call and notice of each special meeting at least 48 hours prior to Special Meeting, stating the time, place and purpose of the meeting and the business to be transacted, and only the business stated in the call and notice shall be transacted at the special meeting.
- 6.5.1.3 6.413 Waiver of Notice. Either the call or notice of a special meeting or any limitations as to the business to be transacted, or both, may be waived by the written consent of every member of the Board of Directors. Any irregularity in or failure of notice of a meeting of the Board of Directors shall not invalidate the meeting or any action taken.
- 6.5.1.4 6.42 Meeting Requirements. Any one or more members of the Board may participate in a meeting of the Board by conference telephone or other electronic format that allows all persons participating in the meeting to hear one another at the same time. Participation by such means shall constitute presence in person at such a meeting.
- Quorum and Vote. A majority <u>five6</u> members of the Board of Directors shall constitute a quorum for the transaction of its business. Except as otherwise provided by law, the vote of a majority of the Board of Directors members present at the time of the vote shall be the act of the Board of Directors if a quorum is present. If a quorum is not present, those present may adjourn the meeting from day to day, or to a later date.
 - 6.5.2.1 6.43 The Board may take action without meeting if 3/4 members of the Board consent in writing to the adoption of a resolution authorizing the action.
- Minutes. The Secretary shall keep written minutes of each meeting of the Board of Directors, recording the matters considered at the meeting and the actions taken. Minutes shall be distributed to the members of the Board of Directors for approval at the next meeting and thereafter signed by the Secretary and filed with the Chapter's records.

6.6 REPORTS OF THE BOARD OF DIRECTORS

6.6.1 — 6.51 Report to Members. The Board of Directors shall render a full report in writing to each annual meeting of this Chapter of the condition, interests, activities and accomplishments of this Chapter, making such recommendations with respect thereto as it deems proper.

6.6.2 Report to Institute. The Board of Directors or the Secretary shall make a written report to the Institute at such times as the Institute requests of the matters and in the form required by it.

6.7 6.6 COMMITTEES AND COMMISSIONS

6.7.1 <u>6.61</u> Formation and Composition. The Board of Directors may form committees and commissions to carry out the work of the Chapter. The charge and duration of each committee or commission shall be determined by the Board of Directors. The members of committees and commissions shall be appointed by the President with the concurrence of the Board of Directors.

ARTICLE 7

- 6.7.1.1 —Committee Chairs. Each committee is to be shall be run by a Chair who is assigned by the President, with the concurrence of the Board. Standing Committee Chairs shall report to the Director overseeing that committee.

 Ad Hoc Committee Chairs shall report to the Board in General.
- 6.7.1.2 Each committee shall submit a written report simultaneously to the President, Vice President/President-Elect, and Secretary at least 48 hours prior to the next regular Board Meeting.
- 6.7.2 Standing Committees. Permanent committees essential to the operations of the Chapter.
 - 6.7.2.1 Standing Committee Composition: Chapter President and Vice
 President/President Elect are members of each Standing Committee and
 shall be invited to all meetings and immediately notified of all proceedings
 and actions. One Director shall be assigned by the President, with the
 concurrence of the Board, to each Standing Committee to monitor its
 activities and to serve as advisor to that Committee's Chair.
 - 6.7.2.1.1 Subcommittees: Standing Committees may include Subcommittees.
 - 6.7.2.1.1.1 Subcommittee Reports: Subcommittees report to the Standing

 Committee Chair. Subcommittee reports shall be collected and submitted by the Standing Committee Chair as part of the Standing Committee's Report.
 - 6.7.2.2 Standing Committees: The following are the Standing Committees, and their subcommittees, of this Chapter:

- 6.7.3 Ad Hoc Committees: Committees of limited duration and which are secondary (ancillary) to the operations of the Chapter.
 - 6.7.3.1 Ad Hoc Committee Composition: Chapter President and Vice
 President/President Elect are members of each Ad Hoc Committee and shall
 be invited to all meetings and immediately notified of all proceedings and
 actions.
 - 6.7.3.1.1 Nomination Committee: Is an Ad Hoc Committee formed and Chaired by Vice President/President Elect.
 - 6.7.3.1.1.1 Nomination Committee Composition: This committee shall consist of the Vice President/President Elect, the Immediate Past President, and any additional members selected by the Vice President/President Elect.
 - 6.7.3.1.1.2 Nomination Committee Responsibilities: This Committee shall seek out and vet qualified candidates who are willing and able to server as elected Officers and Directors of this Chapter. This Committee shall also shall seek out and vet qualified individuals to Chair other committees as needed. This Committee shall submit their nominations to the Board in a timely manner to allow sufficient time for Chapter consideration and voting.

ARTICLE - 7 FINANCES

7.1 7.0 FINANCES

- 7.1.1 Budgets and Appropriations. Prior to the beginning of every fiscal year, the Board of Directors concurring vote of two-thirds of the Board of Directors total membership shall adopt an annual budget showing in detail the anticipated income and expenditures of this Chapter for the immediately succeeding year.
- 7.1.2 <u>7.02</u> Expenditure Limitations.

- 7.1.2.1 7.021 General. No member, officer, director, committee, eommission, employee or agent of the Chapter shall have any right, authority or power to expend any money of the Chapter, incur any liability for or in its behalf, or make any commitment that will or may be deemed to bind the Chapter to an expense or liability unless such expenditure, liability or commitment has been budgeted and authorized by the Board of Directors or a specific resolution at a meeting of the Chapter.
- 7.1.2.2 The Board of Directors. The Board of Directors shall not expend or authorize expenditures in any fiscal year that exceed the estimated income of the Chapter for the year unless specifically authorized to do so by two-thirds majority vote of the Board of Directors at a duly called meeting of the Board of Directors. Themembers provided, however, that the Board of Directors may enter into leases and employment contracts for terms longer than one year and may set aside a reserve to be funded with a portion of the Chapter's income in one or more fiscal years, which may be expended in subsequent years without regard to estimated or actual income or expenditures for such years.
- 7.1.3 Peview of Financial Records. At appropriate intervals, the Board of Directors shallmay employ a firm to prepare a compilation of the financial records of the Chapter as the basis for a financial report to the members.
- 7.1.4 Fiscal Year. The fiscal year of this Chapter shall be calendar year.

7.2 REAL AND PERSONAL PROPERTY

- 7.2.1 Authority. In order to carry on its affairs and exercise its powers this Chapter may acquire and dispose of real and personal property for its own use.
- 7.2.2 Gifts. Only the Board of Directors shall have any right or authority to solicit or accept any gift, bequest or devise for or on behalf of this Chapter; it shall not accept any gift, bequest or devise that will not promote the objects and purposes of this Chapter, or that will place an undue financial or other burden on this Chapter.

7.3 7.2 DIVIDENDS PROHIBITED

An unencumbered balance of income at the close of a fiscal year shall never be distributed as profits, dividends or otherwise to the members of this Chapter.

7.4 7.3 INSTITUTE PROPERTY INTERESTS

This Chapter shall not have any title to or interest in any property of the Institute nor be liable for any debt or other pecuniary obligation of the Institute. The Institute shall not have any title to or interest in the property of this Chapter, and the Institute shall not be liable for any debt or other obligation of this Chapter.

ARTICLE 8

ARTICLE - 8 ——GENERAL PROVISIONS

8.08.1 EXECUTIVE OFFICE

- 8.1.1 The AIA/Central Kentucky Chapter, Inc. currently does not have any administrative and/or executive offices or an Executive Director.
- 8.1.2 The administrative and executive offices of the Chapter shall be in the charge of the Executive Director, if retained under contract by Board of Directors. The Executive Director shall be responsible for the administration of the affairs of the Chapter and such other duties as the Board of Directors may assign. Specifically, the Executive Director shall:
 - 8.1.2.1 Serve as assistant Secretary and assistant Treasurer to perform such duties as the Secretary and Treasurer may delegate;
 - 8.1.2.2 Employ such staff as the Board of Directors may authorize to perform the duties assigned by the Board of Directors;
 - 8.1.2.3 Attend all meetings of the Board of Directors as a member ex officio without vote; and
 - 8.1.2.4 Make reports to the Board of Directors on the affairs and business of the Chapter.

8.2 RECORDS OPEN TO MEMBERS

8.2.1 The correspondence and the minute books, the Treasurer's books of account and the Secretary's records of this Chapter, except confidential matters relating to membership applications and bestowal of honorary memberships, shall be open to inspection by established via the Board of Directors, by any member of this Chapter in good standing.

8.3 8.2 PARLIAMENTARY AUTHORITY

Newly Revised shall supplement the rules and regulations adopted by this Chapter and shall govern this Chapter, the Board of Directors, and the Chapter committees in all cases in which such rules are applicable and are not inconsistent or in conflict with law, these bylaws or the rules and regulations adopted by this Chapter or by the Board of Directors.

8.4 8.3 LIABILITY, INDEMNIFICATION AND INSURANCE

- 8.4.1 <u>8.31</u> Liability. In the absence of misconduct, fraud or bad faith, the present and former officers, directors and <u>employees employees</u> of this Chapter shall not be personally liable for its debts, obligations or liabilities.
- 8.4.2 8.32 Indemnification. If a director or officer of the Chapter is made a party to any civil or criminal action or proceeding arising from the performance by the director or officer of his or her duties on behalf of the Chapter, then, to the full extent permitted by law, the Board of Directors by affirmative vote of a quorum of its members who are not parties to the action or proceeding, may indemnify such director or officer for all sums paid by him or her in the way of judgments, fines, settlements, and reasonable expenses, including attorney's fees actually and necessarily incurred, in connection with the action or proceeding.
- 8.4.3 8.33 Insurance. The Board of Directors may authorize the purchase and maintenance by this Chapter of such insurance on behalf of the present and former officers, directors, employees and persons acting in any other capacity at the request of this Chapter as may protect them against any liability asserted against them in such capacity, whether or not this Chapter would have the power to indemnify such persons under applicable law.

ARTICLE 9

8.5 ——ETHICS

8.5.1 Ethics Charges. This Chapter shall not adjudicate any claims of violations of the Code of Ethics and Professional Conduct. All such claims shall be referred to the Institute's National Ethics Council for adjudication.

ARTICLE - 9 AMENDMENTS

9.1 9.0 AMENDMENTS AT MEETINGS OF THIS CHAPTER

- 9.1.1 9.01 Notice of Proposed Amendments. These bylaws may be amended at any meeting of this Chapter by two-thirds vote of the members present, provided that notice of the proposed amendment and the meeting at which it will be voted on is given to the membership not less than 30 days prior to the date of the meeting.
- 9.1.2 Bylaws Relating to Assigned Members. It shall require a vote of not less than two-thirds of the assigned members of this Chapter who are present at the meeting to amend a bylaw relating to such assigned members.
- 9.1.3 9.1—AMENDMENTS BY THE BOARD OF DIRECTORS
- 9.1.4 9.11 Conformity with Institute Bylaws. The Board of Directors, without action by a meeting of this Chapter, [shall/may] amend any of these bylaws as may be necessary for conformity with Institute Bylaws. These bylaws, and any amendments to them, shall be forwarded at the request ofto the Secretary of the Institute for review for conformity with Institute Bylaws.
- 9.12 Delegation of Authority. The Board of Directors shall be authorized to amend specific provisions of these bylaws if the power to do so has been delegated to it by a two-thirds vote of the members of this Chapter eligible to vote thereon.
